Dickson asked if there is only one entrance and if there are plans to make an entrance on SH-37. Colvin stated he plans to take care of this when the property is leased. He stated maybe an entrance can be made at the southwest corner of the property. Dickson stated he is concerned if this is a daycare it will create much more traffic. He stated this is a prime retail location and he does not see daycare being the right fit for the property. Colvin stated the city can't support a Walgreens or CVS.

Hughes asked about the distance from the liquor store and the dispensary and if that is allowed for daycare. Perryman stated since they pre-exist it is allowed.

Colvin stated he spoke to Braum's and Casey's and they want to buy a property and he wants a long-term lease. Smith stated she has public safety concerns. Buck asked if a bus can turn around in the parking lot. Colvin stated the parking lot goes around the building to exit. McLeroy asked if we can require another entrance or exit, and Perryman stated not without changes to the building or parking lot. He stated the city has no control over the design but can negotiate conditions, and curb cut could be condition of C-5 zoning. McLeroy stated he has no problem with the proposed use of the property.

Schoening stated anything on corner will have congestion issues. He suggested a traffic impact study and stated ODOT may have data to look at. Perryman suggested tabling this item until City Manager initiates discussion with ODOT.
